

# **INUUC Progress Report**

# Introduction

Our new Spokane UU Community was formed on July 1, 2020. Following a year of struggle, frustration, and disappointment, a total of about 100 UUs left our 133 year old congregation at UUCS to begin a new adventure. Some of us resigned in the spring of 2020, 49 people submitted a group resignation on July 1 and some left later. All acknowledged that UUCS was no longer a place where we belonged.

Calling ourselves NewUU Spokane, we flailed and floundered for a bit, working to create a semblance of order out of chaos. A Forum was created to share information and communicate with each other, and a weekly emailed Newsletter followed. We held Town Halls on Zoom to share feelings and ideas, hopes and fears. People used their own resources to provide technical resources, and support our Sunday "Soul Weaving" services, brought with us from UUCS.

Mid July, all interested were invited to meet via Zoom with the UUA regional leads for this area, and they were supportive and helpful. Slowly, our community evolved and formed Circles to address things like Pastoral Care, Finances, Healing, and Communications. Soon more Circles were formed and their many activities and accomplishments are described in this Progress Report.

At this six month point in our history, much as been accomplished, and more awaits doing. Some are frustrated with the slow pace of actions, others express dismay that we are moving too quickly. We work to find the balance between comfort and fear, inertia and headlong activity. Some new people have found us, and we welcome their fresh eyes. We struggle with issues of inclusion and exclusion, and want to fully embody "all are welcome here" in a deep and meaningful manner as we create our own beloved community.

## Alliance for Racial Equality (ARE) Circle

Looking ahead, we plan to work with our Pacific NW Healthy Congregations Team, specifically Rev. Carol McKinley, who is a very experienced leader of covenanting processes in congregations.

# **Finance Circle**

On July 18, 2020, Ian White started a Finance Circle with a post on the Forum and a call for others to join in. Cheryl Conn and Marie Bjork-Haugen were his first volunteers.

Our UUA Regional staff advised us that one of our first tasks as a community was to find a fiscal sponsor so we could accept gifts and pledges, and pay for community needs. After some research, we contracted with the Smith-Barbieri Progressive Fund, a well-respected local 501(c)(3) organization, for a period of up to one year. The Fund generously covers all transaction expenses, and charges no fees.

We began accepting donations in September, and gratefully appointed Stephanie Samson as our volunteer bookkeeper and liaison between our community and the Fund. The Finance Circle solicited budget requests from each Circle, and compiled them in a community-wide budget, which was shared on the Forum, and reviewed by the IRC at their first meeting on October 11.

Since then, we have received over \$19,000 in donations from approximately 50 people. In addition, we have developed a process for reviewing, approving, and paying expenses, and provided monthly financial reports on the Forum.

Looking ahead, we plan to develop budget priorities in case sufficient funds for all requests are not available, and continue to closely monitor and manage our resources.

Sarah Millspaugh to schedule a Sunday sermon on healing and we will be holding a Town Hall on January 13<sup>th</sup> (mark your calendars) to explain all of this to you and to introduce everyone and answer your questions.

# Interim Representative Circle (IRC)

At a Town Hall on September 3, our community decided to form two significant Circles. One was a Circle charged with making decisions for our new community for a period up to one year. Elizabeth Love Sheehan and Marie Bjork-Haugen volunteered to convene and facilitate this Circle of Circles.

Each Circle was asked to select two representatives to represent them, and volunteers were sought for two Member At Large positions. Thus, our group of 24 people (including facilitators) was formed. First called the "Interim Decision Making Circle," members renamed themselves "Interim Representative Circle" to better reflect the intention of the group to represent all voices in our community. As Circles are formed, complete tasks, and disband, new IRC representatives are welcomed, and those who have completed tasks are thanked for their participation and move off the IRC.

Since then, we have met monthly and began getting to know each other and the work of the Circles represented. We agreed to norms for interacting with each other, and reviewed and discussed our overall budget. Nine members participated in a day-long UUA training on board development, and others are beginning an 8-month UUA leadership program in January.

In addition, the Naming Circle shared their process and recommendations, and asked the IRC to finalize a permanent name for our new UU community. We are now the Inland Northwest Unitarian Universalist Community, IN UU Community, INUUC. We also agreed to create this Progress Report to inform our community of what we have accomplished in our first six months.

Looking ahead, we formed a Circle to explore options for affiliation with the UUA and bring recommendations back to the IRC. This Structural Documents Circle is charged with then coordinating the tasks necessary to become part of the UUA, and will bring in others to assist with specific needs.

#### Soul Weaving

In February 2020, Maureen Smith started the process of creating Soul Weaving because many at UUCS wanted an alternative service to Todd Eklof's mostly humanistic services. A proposal to the church leadership emphasized the value of adding a supplemental service at UUCS focused on spirituality and emphasizing the UU principles. Permission was given in late March to begin Soul Weaving gatherings, but before that happened, Governor Inslee announced a state-wide shutdown of most meetings in order to slow the spread of COVID-19.

So, on April 12, the first Zoom Soul Weaving Service was held! Rachelle Strawther offered to use her ZOOM account and to assist with the technology. Maureen, Rachelle, and Kelly Rae Matthews planned and presented the first couple of services and later added anyone who chose to be involved.

During the month of June, a number of UU's left UUCS, taking Soul Weaving with us as the base for our new Unitarian Universalist community. In August, our Circle created a Mission Statement, and we strive to embody its charge in the Soul Weaving services: Soul Weaving is an inspiring space for those seeking community, equity, hope, and justice. Through our UU Principles, world religions, and diversity of lived stories, we will help each other create lives filled with curiosity, compassion, and empathy, feeding us to work together for a better future.

The Soul Weavers schedule, organize and produce the services, including reaching out to and working with visiting ministers and speakers. This group also finds and gets copyright permission for the music we use, Lay Lead the services, teach others how to do this, run the coffee hour and do back-up tech roles. Some 20 people participate periodically in our services, in addition to the many UU Churches and their ministerial staff who have reached out in support.

Looking ahead, we plan to expand our planning groups, hire a tech person, create ways to get more participation by more INUUC members in services, purchase memberships in music 'libraries.' We plan to continue to present a wealth of diversity of all kinds in the people, themes, music, religions, and theories through guest speakers and ministers as well as the abundance of knowledge and spirituality within our INUU Community.
