The proposal of the Finance Circle to open a bank account at Umpqua bank was reviewed and discussed. The Governing Circle decided to ask the Finance Circle to investigate banking with a local credit union (STCU or Numerica). Linda will relay this charge to the Finance Circle. Libby will connect the Finance Circle with her contacts at Numerica.

Linda will secure a meeting room for the Governing Circle meetings for the rest of the church year.

Linda presented the hymnal that was gifted to the INUUC Governing Circle by the UUA Governing Circle. This hymnal will be signed and dated by Linda and all future INUUC Governing Circle presidents. The Governing Circle president will maintain possession of and responsibility of this hymnal for their tenure.

To model the tenants of dynamic governance.

To take in the support and guidance of the UUA and the larger community in which we sit.

Governing Circle Covenant

In addition to upholding the INUUC covenant, INUUC Governing Circle members will:

We will prepare for each gathering and participate fully each time.

We will communicate supportively and share the work.

We will honor both intention and impact.

We will recognize (and act) when the process needs to be paused, altered, or abandoned.

We will consider those not represented in the room in all our decisions.

We will challenge our personal and group assumptions.

We will honor all learning styles.

We will take the time necessary to consider our options and make decisions together.

We will name our expectations and be open to all potential outcomes.

We will leave room for new and emerging leaders.

The makeup and responsibilities of the Coordinating Circle was discussed. The Governing Circle decided on the named Coordinating Circle for the heretofore named Circle of Circles.

Leadership Development

The leadership position of the Coordinating Circles are Leader, Facilitator, and Secretary. Sara, in her position of the Governing Circle representative an originator of the Coordinating Circle, will determine, with Governing Circle consent those leadership positions. The Governing Circle will continue to appoint the leadership positions of the Coordinating Circle going forward.

The Mission of the Coordinating Circle is to carry out the mission of the church.

The responsibilities of the Coordinating Circle, given to them by the Governing Circle, are to:

- 1. Report monthly, in its capacity as an administrative circle, to the Governing Circle on writing and/or person.
- 2. Participate in the annual planning session with the Governing Circle every February.
- 3. Translate the annual vision/goals for the congregation into goals and objectives and to, in partnership with the congregation circles, put these goals and objectives into action.
 - a. These goals and vision, given to the Coordinating Circle by the Governing Circle, will be the outcome of the annual planning session each year.
- 4. Manage the church calendar of events.

The Coordinating Circle will initially meet once monthly at a time to be determined.

The primary purpose of the Coordinating Circle is to fulfill its mission stated above and to function as a communication conduit and a problem-solving body.

The Governing Circle read, reviewed, and discussed the handouts, Dynamic Governance for UU Congregations from Renee Ruchotzke and Dan Hotchkiss's Governance and Ministry Model.
